Subject: Regarding to Grant of Provisional NOC (No Objection Certificate) to start a new law college i.e. Dr. B.R Ambedkar Law College, Kurukshetra.

In reference on the subject cited above.

You are hereby granted Provisional NOC (No Objection Certificate) to start a new Law College viz. Dr. B.R Ambedkar Law College, Kurukshetra **under self financing basis** from the session 2024-25 with the following terms & conditions:-

1. The endowment fund in the shape of **FDR of Rs. 50 Lakh and Bank Guarantee of Rs. 1 Crore** is to be deposited with Department of Higher Education, Haryana, Panchkula **within in 30 days of issuance of Provisional NOC.**
2. No financial assistance/grant in any form at any stage will be given by the State Government. The institution will have to bear all the recurring and non-recurring expenditure of the classes for all times to come. The building intended for educational occupancy will not be used for any other occupancy of any institution/college.
3. The State Govt. shall not take over the college at the request of the institution in any case.
4. The institution will seek affiliation from the concerned affiliating University/Bar Council of India/UGC for the courses and same will be sent to this office by the college and shall follow all other conditions imposed by the concerned affiliating University//Bar Council of India/UGC and State Government.
5. The institution will follow all the guidelines of the University Grants Commission/concerned affiliating University Bar Council of India/UGC and State Government in the matter of recruitment of staff and staff strength.
6. The institution will appoint qualified Assistant Professors and other staff in required number as per norms and submit report to this office/Government. The institute shall also submit a detailed report regarding the number of students enrolled in the classes for which the NOC is issued after the commencement of the academic session.
7. The faculty required as per norms shall be recruited before the start of the courses/Classes (both teaching and non teaching staff and as per affiliating university/UGC/State Govt.norms)
8. The separate building for the new college along with other existing run institutions shall be indicated on the land plan and submit to this office before the start of the courses/classes. However, no institutions/college shall be run on the same premises where NOC has been granted.

9. In the admission of the students, there shall be reservation of seats for SC/BC/OBC, Handicapped, Ex-servicemen, Sports Persons, Freedom-Fighter and any other reserved category as per the State Government Reservation Policy issued from time to time.
10. No discrimination on the basis of caste, creed, colour, sex and religion shall be made while recruiting the faculty.
11. Tuition fees and others charges will be as per the norms of the affiliating University/State Govt.
12. Library books as per norms and relevant subject shall be purchased before the start of the courses/Classes.
13. The Government can impose any other conditions (s) at any time which shall be binding on the College Management and also agrees to abide by any instructions issued by Government time to time.
14. Provisional NOC for the first year is given because the basic minimum facilities/Infrastructure is partially available to run the proposed course (s). However, the NOC can be extended another two years on year-to-year basis. But if the institution fails to develop the infrastructure as per terms and conditions then it will not be extended. The college shall develop all the requisite facilities within the two years of the provisional NOC. If the performance of the institution is found satisfactory, a regular NOC shall be granted after a re-inspection of the intuition before commencement of its 3rd year of running.
15. In case of any violence/contravention/misrepresentation/misconduct detected at any stage shall result in withdrawal of "NO objection Certificate" without any information and legal action against the defaulting society/Institution. The endowment fund/Bank Guarantee submitted by the institution/society shall be forfeited to continue studies of the enrolled students, payment of salary of the staff and other expenditures being fit. The Bank Guarantee and FDR is to be renewed time to time.
16. The institution/trust shall submit a progress report pertaining to the infrastructure/financial status/performance of the institute to Directorate at the end of its first year for review and grant of constitution of provisional NOC by 31st April of the end of the first year and another progress report by 31st March of the end of 2nd for the consideration for the Permanent NOC falling with the provisional NOC shall be withdrawn.
